# Lake Shore Adopts Revised Zoning Ordinance

In November of 2023, the Lake Shore City Council adopted a revised zoning ordinance which includes changes to the bluff setback from 30' to 50' which was required by the Minnesota Department of Natural Resources. The ordinance does contain a provision to allow additions on structures constructed prior to 1990 provided they meet the following:

- They were permitted and constructed after July 6, 1990;
- Are not located in the bluff impact zone;
- Do not encroach further into the required setback;
- Comply with other applicable setback requirements of the underlying district;
- Do not exceed allowable impervious surface coverage standards of the shoreland district.

The MN DNR also required the city to limit the size of guest quarters above garages to 700 square feet. The city also placed a limitation on "shouses" (large storage buildings with living quarters). The storage area of a building may not exceed 150% of the living space in shoreline zone (R-2) or 200% in the low-density residential zone. To exceed these percentages a conditional use permit would be required. A complete copy of the Zoning & Subdivision Ordinance may be found on the city website along with a Zoning Summary of the ordinance.

Some people see my snags and say, why don't you cut them down? Usually I just say, they're beneficial and leave it as that. I never have to explain to the birds. If they're truly wondering, I tell them they are a clear perch for raptors, the cavity

nesters (chickadees, nuthatches, woodpeckers) have an insulated home from intense cold and heat. The birds are hiding seeds in the bark preparing for winter or looking for insect food to feed they're chicks. It's a perch when needing to quickly escape the berry filled understory or wait their turn at the feeder. The other reason? I love all the interaction happening in front of me. That's why I leave the snags.

### **Roads Report**

Update Provided By: Wayne Anderson, Liaison to Road Wastewater Committee

The Road/Wastewater committee has a busy 2024 planned.

This year we will overlay or reconstruct several streets which include Balsam Lane, Woodland Road, Abbey Way and Lincoln Green. Also included are some Wastewater projects at Harold Lane, Esther Lane and at County Road 78. This work will be completed by Anderson Brothers based on their low bid of \$390,557.44. The engineer's estimate was \$443,241.30.

In 2024 we will chip seal the roads that were overlaid or reconstructed in 2023 which included Nottingham Road, Fernmont Road, Bent Arrow Road and Waseya Woods Drive. We have been pleased with the performance of the chip sealing on past new road projects.

The County inspected the Fritz Loven Bridge and determined that it needs to be replaced or removed based on its condition. A 22-foot-wide bridge will be necessary to meet state requirements for funding. The City received approval of 5 variance requests submitted to the state variance committee. In receipt of the approval letter Widseth will finalize the bridge plans and submit the plans to the State Bridge Engineer for approval.

Work is underway to finish the Gull Lake Trail along CR 77 from CR78 to the City Limits, where Nisswa will finish the trail to connect to the Paul Bunyan trail in Nisswa. Fairview Township will complete their last segment this year. The segment from the quarry to the city limits still needs to be completed and a funding application to the Greater Minnesota Regional Parks and Trails will be submitted this summer to fund this segment.


#### City News
